## **DESCRIPTION OF REQUIREMENTS**

The United Nations Office at Nairobi (UNON), on behalf of Climate Technology Centre and Network (CTCN), United Nations Environment Programme (UNEP) invites qualified interested firms to submit Expression of Interest (EOI) to participate in the upcoming solicitation for provision of technical assistance implementation of the Technical Assistance on "Support the transition to a circular economy in Costa Rica."

The United Nations Environment Programme (UNEP) on behalf of the Climate Technology Centre and Network (CTCN) requires the services of an institution to deliver the technical assistance as approved by National Designated Entity from Costa Rica. The overall objective of the Technical Assistance is to support the transition to a circular economy in Costa Rica by developing a National Circular Economy Strategy.

The main activity of this assistance is the development of a National Circular economy Strategy to support the transition to a circular economy in Costa Rica and therefore increase climate resilience and reduce greenhouse gas emissions in production processes, extraction and distribution of resources, and promote changes towards more sustainable consumption patterns in the Costa Rican population. Some of the expected outcome, outputs and activities are;



- Development of a detailed work plan and related communication documents
- Mapping of existing actors and initiatives in circular economy in Costa Rica and planning of socialization and validation workshops
- Development of a first draft of a national circular economy strategy and preliminary indicators
- National circular economy strategy and indicators validated
- Dissemination and training strategy for the use of the step-by-step guide to municipalities and key stakeholders and its implementation in three pilots
- Updated step-by-step guide on circular economy

The complete details of the requirement will be provided in the tender documents that will be issued to bidders after this request for EOI is closed.

## SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The Climate Technology Centre and Network (CTCN) is the operational arm of the United Nations Framework Convention on Climate Change (UNFCCC) Technology Mechanism and co-hosted by the United Nations Environment (UN Environment) in collaboration with the United Nations Industrial Development Organization (UNIDO) and supported by 11 partner institutions with expertise in climate technologies. The mission of the CTCN is to promote accelerated development and transfer of climate technologies at the request of developing countries for energy-efficient, low-carbon and climate-resilient development.

CTCN provides technical assistance to the countries usings its own funds (which it recives through voluntary contributions of donor). The requests for Technical Assistance (TA) are submitted to the CTCN by the National Designated Entity (NDE) of the respective country. In this present case the CTCN has developed a response plan and proposal which was submitted to Costa Rica for approval.



### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<a href="www.ungm.org">www.ungm.org</a>) with the UN Secretariat in order to be eligible to participate in any solicitation. #### Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future:
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
