- The Islamic Republic of Pakistan has applied for financing from the Asian Development Bank (ADB) toward the cost of Second Power Transmission Enhancement Investment Program – Tranche 3. Part of this financing will be used for payments under the contract named above. No nationality restrictions apply, other than any restrictions arising from ITB 4.8.
- 2. The National Transmission and Despatch Company (NTDC, "the Employer") invites sealed bids for the "Procurement of Plant, Design, Supply, Installation, Testing and Commissioning of Three (03) 220 kV Transmission Lines Associated with Lahore North Sub Station.". The works mainly include design, manufacturing, delivery, installation, testing, commissioning, and completion of works and services at turnkey basis, as detailed and specified in the Bidding Document. The Time for Completion of the whole of the Facilities shall be 540 days from the Effective Date as described in the Contract Agreement.
- International competitive bidding will be conducted in accordance with ADB's <u>Single-Stage</u>: <u>One-Envelope</u> bidding procedure and is open to all Bidders without nationality restrictions.
- 4. The bidder must satisfy the evaluation and qualification criteria in Section 3 of the Bidding Document of the subject bid, including the following key requirements:

Participation in at least one (01) contract for design, supply and installation of minimum 50km of 220kV or higher voltage transmission line that were successfully commissioned within the last 10 years and operating for at least 2 consecutive years as of the bid opening date, and similar to the proposed contract, The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements)
